Forfeiture of Options and Issue of New Options

Azure Healthcare Limited ("Azure") advises of the forfeiture of 5,000,000 Options under the terms of the Azure Share Option Plan ("Plan"), which were issued pursuant to the Plan with an expiry date of 30 July 2020.

Azure also advises of the granting of 3,839,754 Options pursuant to the Plan. Of the total:

- (a) 1,919,877 Options will be issued with an exercise price of \$0.10 (10 cents) per Option and an expiry date of 18 March 2022; and
- (b) 1,919,877 Options will be issued with an exercise price of \$0.13 (13 cents) per Option and an expiry date of 17 March 2023.

Azure has also agreed to offer 2,792,552 Options subject to shareholder approval pursuant to Chapter 10 of the ASX Listing Rules, with such approval to be sought from shareholders at the next AGM.
